**Civilian Response to Active Shooter Events**

The Civilian Response to Active Shooter Events (CRASE) course, designed and built on the Avoid, Deny, Defend strategy developed by ALERRT in 2004, provides strategies, guidance, and a proven plan for surviving an active shooter event. Jason Place and Troy Mizell, Deputy Marshals from the Northern District of Ohio's U.S. Marshals Service, will kick off the 2017 Annual Conference covering topics including the history and prevalence of active shooter events, the role of professional guardians, civilian response options, medical issues and drills.

He has been a Deputy U.S. Marshal for the past 18 years, and until recently was a Supervisory Deputy. He is currently serving as a Judicial Security Inspector, assisting Senior Inspector Jason Place.

This thought-provoking and entertaining lecture by trial attorney Jeff Wahl presents a selection of topics relating to expert witnesses in medical-legal litigation, the conduct of physicians in the operating room and elsewhere (and their civil/criminal consequences), and the related subject of published medical literature. We will cover expert witness backgrounds and qualifications, some of the seemingly incredible (but true) things that attorneys can learn from expert CVs, what doctors say and do in depositions and in trial, and the related subject of expert (dis)honesty in clinical research. Many of the examples used to illustrate and educate are true and come from cases in which Jeff was involved, one scenario actually involves Suzanne Somers, and another describes the astonishing scientific impact of *Cocoa Puffs* cereal. So sit back, suspend your disbelief, take out your *Thighmaster* and prepare to dive into the world of expert witnesses and other oddities in healthcare litigation.

**Jeffrey R. Wahl, Esquire**

Jeff graduated from Franklin & Marshall College and CWRU School of Law. He handles civil litigation matters primarily relating to medical-legal topics (malpractice and wrongful death), representing clients in Ohio and across the country. He is a recognized expert on the often contentious and uncomfortable relationship between law and medicine. To that end, Jeff founded a software company to improve physician communications with patients, and to improve patient comprehension of complex medical and surgical information.

Jeff is a frequent lecturer to physician and other medical groups, departments at major academic medical centers, clinical drug and device research professionals, and one of the leading graduate programs in Health Communications (at Northwestern University in Chicago). He has served as the only non-physician member of the editorial board of a hematology/oncology journal, and has written extensively and been quoted in other medical publications on medical-legal topics. He is the co-author of a chapter on legal issues in pediatric anesthesiology in the 10th edition of the pre-eminent textbook on the subject, *Smith's Anesthesia for Children and Infants*.

Jeff was lead counsel in litigation involving a national chain of plastic surgery clinics regarding its false and deceptive sales, marketing and informed consent practices. He also represented one of the relators in the Federal Qui Tam case against an international pharmaceutical manufacturer which engaged in illegal nationwide schemes to push sales of its three blockbuster drugs through "off label" uses, misrepresented the safety and efficacy of those drugs in specific patient populations, and used improper financial inducements to promote its blockbuster drugs among prescribers. While he would have liked to have retired on a private island in the Caribbean after that case was settled with the United States Attorney in Boston (for \$3 billion), he only earned a teeny, tiny piece of the legal fees generated in the case, so he continues to work very hard in courtrooms here and elsewhere (but still dreams of the private island).

**Vicarious Trauma and Self-Care (Part 1)**

This program is designed to help you understand vicarious trauma and the impact it has on yourself and your service to clients. Elizabeth will explore the way that working with the traumatized population can take its toll on court reporters and captioners, and how to identify and manage when this occurs. **For the Record: A Court Reporting Documentary**

Stenographers, the quiet first-row witnesses of history, are the subject of this inspiring documentary that takes us on a tour through the history of stenography and sheds light on a profession that many know very little about. For this group of people, the better they are at their job, the more invisible they become.

*For the Record* takes us into the world of the usually unnoticed court reporters, live captioners, and CART captioners. Captioner Dee Boneau trains to challenge rock star court reporter Mark Kislingbury, verified by Guinness Book of World Records as the fastest court reporter on Earth, as he aims to beat his own speed record and write 400 words a minute. From a group of dedicated captioners who worked around the clock on 9/11 to ensure those with hearing impairments were kept informed, to Stan Sakai, a young CART captioner redefining the craft for the next generation, *For the Record* takes us beyond the traditional idea of a court reporter and captioner and into the lives of the "keepers of the record."
