# Domestic Terrorism: The Who, What, When, and Why (Ref. Article III, Sects. 3.02, 3.10, and 3.01 of the CE Program Rules)

#### The Importance of Court Records in Shipwreck Research (*Ref. Article III, Sects. 3.02 and 3.10 of the CE Program Rules*)

When discovering shipwrecks, many people envision donning scuba gear, jumping into the water, and descending to discover a lost shipwreck on the bottom. However, the truth is that shipwrecks are usually only found after many years of research in libraries and archives. One of the most valuable and important sources of research are court records and testimony, which inevitably follow the loss of any property or lives. These records are important not only for understanding the events surrounding a shipwreck but are also highly valued because of their reliability. Sworn testimony and evidence that is presented in a courtroom are unlike those found in newspapers and other sources. Thus, court records and testimony have figured prominently into several shipwrecks found in Lake Erie. This talk will look at those cases and show why record preservation is so important, even over a hundred years or more.
